1 Fees/tuition

In addition to tuition in the instrumental or vocal major subject the Stuttgart Music School offers participation in ensemble and additional tuition.

Participation without tuition in a major subject is possible.

2 Debtors of fees, origin of the debt and due date of the fees

- 1. Debtors of the fees are:
- a) in the case of students who are minors, the parents/legal guardians,
- b) in the case of adult students, the students themselves,
- c) the person who assumed the obligation to pay the fees to the State Capital Stuttgart by means of a written confirmation.
- 2. Legal representatives are jointly liable.
- 3. The fees are due at the beginning of the school year or semester, the rental fee for the instruments by the first of the following month when the instrument is handed over. If the students have been admitted to the Music School, the obligation to pay exists even if they do not start the tuition for a reason of their own. For students who have reached the age of 28 at the beginning of the school year or will do so in the course of the school year, an adult surcharge of 12 % on the tuition fees will be charged. For students reaching the age of 28 in the course of the school year the adult surcharge will be charged from the following calendar month.
- 4. The fees are due upon the school fee decision. Monthly or 6-monthly payments can be agreed. All payments are to be made to the Stadtkasse Stuttgart with reference to the transaction code stated in the school fee decision.
- 5. There will be no right to tuition if the fees are not paid in time.
- 6. Separate arrangements will be made for co-operation on a case-by-case basis.

3 Discounts

1. A graduated tuition fee will be granted if the same payer books several courses: for 2 courses, 10 % per course for 3 courses, 15 % per course 4 courses and more, 20 % per course.

The reduction for multiple courses shall not apply for a combination of subjects with a supplementary subject.

2. Upon presentation of the State Capital Stuttgart FamilyCard, holders are granted a discount of 20 % on the fees of the Music School. The reduction due to the FamilyCard is valid until the end of the respective semester, when the student turns 17 years old. Upon presentation of the State Capital Stuttgart BonusCard, holders are granted a discount of 90 % on the fees of the Music School. The BonusCard reduction is taken into account retroactively from 01.01. of the calendar year.

The calculation is based on the tuition fee minus any multiple discounts according to paragraph 1. The FamilyCard and BonusCard discounts cannot be combined.

- 3. The discounts according to paragraph 2 will also be granted for the rent of the instrument.
- 4. The one-off registration and processing fee shall be exempted from the discounts according to paragraphs 1 and 2.

5. In the case of a medically certified illness for the duration of more than two weeks a reasonable reduction of the tuition fee will be granted upon request. The reduction is 50 % of the tuition fee for the corresponding period.

4 Exceptions

- 1. Upon request, the school management can provide instruments for ensemble and orchestra work for a limited period without a charge.
- 2. The school management shall be entitled to charge a different fee for co-operation programmes.
- 3. The school management shall be entitled to set course fees for special events beyond the scale of fees on the basis of the costs incurred and regulate sales revenues, as well as cost reimbursements for the provision of special services. This will be published through notices in the respective institutions.
